#### CARES Act Provides Billions of Dollars in Support for Arts Groups and Gig Workers



When Congress passed on March 27, 2020, a \$2.3 trillion CARES Act emergency relief package in response to the COVID-19 pandemic, it was the largest appropriations bill in history. Even then, Congress had to quickly add \$1 trillion more the next month. Many popular federal programs proved to be a lifeline to nonprofit and commercial arts groups and gig workers, including:

- \$8.2 billion in Paycheck Protection Program loans made to the "Arts, Entertainment, and Recreation" sector.
- Millions of self-employed artists and furloughed arts administrators and artists collecting an additional \$600 per week in Federal Pandemic Unemployment Compensation.
- Millions of arts-centric small business and self-employed artists receiving SBA Emergency Injury Disaster Loan advances and low-interest business loans.
- \$300 million in economic relief to support nonprofit cultural organizations through the National Endowment for the Arts, National Endowment for the Humanities, Institute of Museum and Library Services, and the Corporation for Public Broadcasting.
- State and local governments regranting a portion of their federal CARES Act relief funds to provide economic relief grants to local arts organizations.

Amid the COVID-19 pandemic, Americans for the Arts quickly re-programmed its annual National Arts Action Summit (NAAS) on Capitol Hill into a week-long digital conference on April 27 through May 1, 2020. Advocates were given a brand-new experience to engage digitally as well as an entire suite of arts policy webinars to watch again anytime. The nation's top arts lobbyists representing every arts discipline presented more than a dozen educational sessions.

Several key Congressional arts leaders also joined the webinar sessions, including: Senators Susan Collins (R-ME), Brian Schatz (D-HI) and Tom Udall (D-NM), and Representatives Alma Adams (D-NC), Suzanne Bonamici (D-OR), Betty McCollum (D-MN) and Chellie Pingree (D-ME).





### Americans for the Arts Research Confirms COVID-19's Impact on the Arts



Since the first U.S. case was diagnosed, cancellations and closings have been taking place at thousands of arts organizations across the country, two-thirds of the nation's artists are now unemployed, and 12,000 organizations doubt they will survive the crisis. Americans for the Arts leads the four premier national studies tracking the human and financial impacts of the COVID-19 crisis on the arts and we encourage all artists and arts organizations to add their impact to these ongoing studies at ArtsActionFund.org/Covid-19ArtsImpactResearch.

- Nationally, financial losses to nonprofit arts/cultural organizations are an estimated \$12.5 billion as of mid-August 2020. A full 96% have cancelled events and lost an estimated 354 million admissions. An astonishing 67% expect this crisis to have a "severe" impact on their organization and nearly one-third have reduced artistic workforce.
- Artists/creatives are among the most severely affected segment of the nation's workforce. 63% have become fully unemployed and the average financial loss per artist/creative worker is \$22,200. Nationally, they expect to lose \$50.6 billion in income in 2020.
- This new study is designed to strengthen our understanding of the mental health impacts on the general public of sheltering in place, social distancing, and isolation—and to determine if certain activities buffer against those ill effects (including the arts).
