# ARTS & CULTURE SECTOR REPRESENTS 4.2% OF NATION'S GDP & 4.6 MILLION JOBS

U.S. Bureau of Economic Analysis reports that nationally the arts and culture sector was a **\$876.7 billion industry** in **2020**, representing **4.2%** of the nation's GDP, **4.6 million jobs**, and total compensation of **\$446 billion**.

# CA ARTS & CULTURE SECTOR REPRESENTS 7.5% OF STATE'S GDP & 681,211 JOBS

U.S. Bureau of Economic Analysis reports that the arts and culture sector contributed **\$225 billion** to CA's economy in 2020, representing **7.5%** of the state's GDP, **681,211** jobs, and total compensation of **\$109 billion**.

**BONUS:** In 2020, total compensation in CA increased by 3% from 2019.

#### **LOSS OF REVENUE AND JOBS** (Commercial & Nonprofit Arts Organizations Combined)

Between **2019** and **2020**, the U.S. **arts economy** shrank at **nearly twice the rate** of the economy as a whole. Arts and cultural production fell by **6.4%** when adjusted for inflation, compared with a **3.4%** decline overall.

600,000 JOBS LOST California arts and culture value added decreased by **5%** between **2019** and **2020**. In addition, arts & culture employment decreased by **12%**, dropping from **779,932** to **681,211**.

#### **ECONOMIC IMPACT OF NONPROFIT ARTS ORGANIZATIONS & THEIR AUDIENCES**

Nationally, the nonprofit arts industry alone generates **\$166.3 billion in economic activity** annually that supports **4.6 million jobs** and generates **\$27.5 billion** in federal, state, and local government revenue.

• Spending by arts audiences generated **\$102.5 billion** to local businesses.

NONPROFIT ART IS A \$166.3

DRIVER OF OUR NATIONAL, STATE & LOCAL ECONOMY.

In a 2015 study of fifteen cities and counties of CA, nonprofit arts and cultural production generated **\$4.5 billion in economic activity, 132,705 iobs,** and **\$431.5 million** in state and local government revenue.

In San Francisco, for example, nonprofit arts groups generated \$780.6 million in economic activity. Their audiences of 15.6 million people added another \$667.7 million for a total of \$1.4 billion in business for the city and county, and this generated \$131.1 million in local and state government revenues.

#### PUBLIC INVESTMENT IN GRANTS TO NONPROFIT ARTS ORGANIZATIONS & ARTISTS

How much is the federal government investing in the National Endowment for the Arts (NEA)?

Congress allocated **\$180 million** to the NEA in **FY22**. This amounts to just **54 cents** per capita. Ideally, Congress should index \$1 per capita funding to the NEA. For COVID economic relief, Congress also allocated **\$75 million** in CARES Act and **\$135 million** in ARPA funding for distribution by the NEA. Additionally, Congress allocated **\$16 billion** to the SBA for shuttered arts venues plus billions more for PPP and EIDL.

How much did California receive in public funding for the arts and culture?

In **FY21-22**, the state allocated **\$140 million** to the California Arts Council. The California Arts Council also received **\$1.1 million** in federal NEA funds, **\$1,348,900** through ARPA, and **\$760,400** through CARES Act. These funds have benefitted over **1,328** artists and arts organizations. Another **260** nonprofit arts organizations received direct grants from the NEA totaling **\$12,577,000**.

# THE ARTS ARE EVERYWHERE!

- From the north to the south, California is rich in arts and cultural programming and leads as the economic capitol of creativity. California is the State of the Arts.
- California is innovative in its use of the arts to solve social issues. For example, as of June 2017, Arts in Corrections, a partnership between the **California Department** of Corrections and Rehabilitation (CDCR) and the California Arts Council provides arts programming in all 35 state adult correctional institutions. In Los Angeles, the Actors' Gang under the leadership of Artistic Director Tim Robbins, has provided theater arts programming with an emphasis on Commedia dell'Arte techniques for more than a decade.
- Based in Fresno, with service statewide, The Alliance for California **Traditional Arts** provides arts programming focused on the underserved field of traditional arts, rooted in cultural heritage and community-based practice. Expressions such as Native American beadwork, storytelling, songwriting, African drumming, and American folk guitar and guitarra ranchera are intended as familiar and culturally relevant art forms for participants.
- In 2021 the CA State Budget included \$60 million onetime General Fund for the California Arts Council to implement the California Creative Corps Pilot **Program**, a media, outreach and engagement campaign designed to increase: (1) public health awareness messages to stop the spread of COVID-19; (2) public awareness related to water and energy
- conservation, and emergency preparedness, relief, and recovery; (3) civic engagement, including election participation; and (4) social justice and community engagement.
- California Cultural Districts highlight the cultural legacy of our state's most valuable resource—its diversity. From larger, urban areas to uncharted rural locations, each district helps grow and sustain authentic arts and culture opportunities, increase the visibility of local artists, and promote socio-economic and ethnic diversity through culture and creative expression. 14 districts serve as California's inaugural state designated Cultural Districts, highlighting some of the thriving cultural diversity and unique artistic identities within local communities across California.
